a. in order to obtain a license, a person must pay an application fee of \$100.00 in cash or its equivalent to the department of revenue, the department shall administer the application for the license and shall determine, within 30 days of application, whether the applicant is eligible to hold a license, if the department determines that the applicant is eligible to hold a license, the department shall notify the applicant and send the application to the commissioner, if the department determines that the applicant is not eligible to hold a license, the department shall notify the applicant in writing of the reasons for its determination.
